Sealed bids will be received by CARL SANDBURG COLLEGE, 2400 TOM L. WILSON BLVD., GALESBURG, ILLINOIS 61401, hereinafter known as Owner, for **Building D - Patio Entry and Platform Lift**, 2400 Tom L. Wilson Blvd, Galesburg, IL 61401. The work includes modifications to an existing aluminum storefront assembly, in order to introduce new doorways to the new exterior patio. It also includes an all-new handicap lift assembly at the existing College Art Gallery with replacement railings. And, it also includes new floor finishes for a portion of this same interior area.

Receipt of Bids: Bids for “All Work” will be received until **2:00 p.m., local time, Friday, June 14, 2019** by the Owner, at the Business Services Administrative Assistant’s Desk, Carl Sandburg College, Galesburg, Illinois. Bids will be publicly opened in Board Meeting Room (E-200), read aloud and recorded.

Bid shall be held good and not withdrawn for sixty (60) calendar days from the date of bid opening.

Pre-Bid: A “Pre-Bid” Conference will be scheduled on **Thursday, June 06, 2019 at 9:30 a.m. local time**, in the Auditors Conference Room (D-209) of Carl Sandburg College, Galesburg, Illinois. Representatives of all bidding firms are requested to attend, to present any questions they may have and to attend a “walk through” of the project site. Neither the Architect nor Owner will respond to questions verbally regarding the Project outside the Pre-Bid Conference. All requests for clarifications or interpretations outside the Pre-Bid Conference shall be made to the Architect in writing and will be answered by Addendum when appropriate. Addenda items resulting from the Pre-Bid Conference will be disseminated to all registered bidders.

Commencement of the work on the project shall be subject to the discretion of CARL SANDBURG COLLEGE, GALESBURG, ILLINOIS. The Owner reserves the right to waive any irregularities and to accept any or reject all bids when in the opinion of the Owner, such action will serve the best interest of the Owner.

Bids on all work of this contract shall be subject to the provisions of the “Illinois Prevailing Wage Act”, 820 IL CS 130/0.01 et seq., the “Equal Employment Opportunity Clause” - rules of the Illinois Human Rights Commission, the “Illinois Drug Free Workplace Act” and all other applicable and governing laws and ordinances.
